3. Date and time of end of remote e-voting- Tuesday, 27th September 2016 at 5.00 pm. Remote e-voting shall not be allowed beyond the said time and date.
4. Persons who have acquired shares and become members of the Company after dispatch of the Notice of the AGM and holding shares as on the cut-off date 21st September 2016 may cast their votes by following the instructions and process of remote e-voting as provided in the notice of the AGM. However, if the person is already registered with CDSL for remote e-voting then the existing user Id and password can be used for casting vote.
